What's Expected of a Counselor

During General Assembly

- Station yourselves **around the room** not everyone needs to be in the front
 - ♦ Make sure delegates are paying attention
 - ♦ No cell phones
 - ♦ Give out slinkies and/or water if needed
- No playing with cell phones
- Take pictures

During Elections

- Make sure delegates are quiet in line
- Make sure delegates are silent in the election room
- Check that all delegates have their NAME TAG and SAMPLE BALLOT
- No campaign materials visible
- No campaigning in line
- Nice behavior is expected of delegates

During City Meetings

- Let delegates be their own leaders facilitate only. (You lead on Sunday night, coach the Mayor leads for the rest of week.)
- Coach the Mayor on following the agenda (beforehand)!

During County Meetings

- Facilitate filing for office (see directions)
 - ♦ Use the white boards to write delegates' names
 - ♦ Time campaign speeches (30 seconds to 1 minute each)

During Party Meetings

- Facilitate filing for office (see directions)
 - ♦ Use the white boards to write delegates' names
 - ♦ Time campaign speeches (30 seconds to 1 minute each)
- Help delegates work on legislation
 - Let delegates talk out their ideas this can get heated so ensure civility
 - Answer questions (if there are questions you can't answer, ask Daela and/or Courtenay)

During Meals

- Be on time; make sure your delegates are on time
- Counselors eat first and inside the Education Building
- Counselor meetings take place inside during **Breakfast** and **Dinner**. Listen and ask questions if you have them.

General Responsibilities

- **1. Help delegates** to find their cabins, get situated, and become acquainted with you and each other.
- **2.** Advance the Indoor Flag at the beginning of Sunday's first General Assembly and **Retire the Indoor Flag** at the end of Friday's last General Assembly.
- 3. Monitor General Assemblies.
- **4.** Facilitate City, County, and Party meetings. *Allow delegates to be their own leaders*. Be there to answer questions, but try to stay in the background.
- 5. Prepare and supervise elections.
- **6. Supervise all activities** in the chambers and hallways during the legislative session on Friday.
- 7. Set up for all meals.
- **8.** Take trash to the garbage cans each night (or as frequently as needed).
- 9. Assist in managing the Snack Shack.
- 10. Ensure your city's Daily Duty is completed.
- **11. Learn** the *names* of the delegates in your cabin as quickly as possible. Get to know all of them and their interests. Make the delegates feel welcome and part of the group the moment they arrive.
- **12. Go over the handbook** with the delegates. Make sure they understand all of it. (If there is something *you* don't understand or have questions about, ask Daela or Courtenay.)

- **13. Ensure that all delegates understand** what is expected of them during General Assemblies, flag ceremonies, meals, elections, and lights out, as well as at the legislative session on Friday. Attendance is required at all events and appropriate behavior is expected.
- **13. Be prepared** to help facilitate a changing schedule. Have short games, songs, cheers (e.g., "Girls State is What?! DYNAMITE!) ready.
- **14. Watch for signs** of injury or illness, as well as homesickness.
- **15. Lead by example.** Know all procedures. If you aren't sure about something, ask.
- **16. Be available and flexible** to assist delegates and other staff members in any way necessary.

Accountability

As a Counselor at Nevada Girls State, a great deal of trust has been placed in you. Therefore, it's extremely important that you act as both an example to all delegates and a leader.

A few things to remember:


Always use the **Buddy System**, and ensure that delegates are using it, too. Sometimes, this will mean you act as a delegate's buddy (particularly during activities or late at night).

As counselors, you should be modeling the behavior we expect from delegates. It is just as important that you be accounted for by someone else as it is for you to account for your delegates. It is a sign of respect to each other and to your delegates to show that you are making an effort to keep each other safe and accounted for. The buddy system is a simple way to help ensure this happens.

A counselor from your city **MUST** make sure delegates attend all activities and are on time for each one, including meals.

In the event of an emergency, a roster check **MUST** be done! Make sure you have one with you at all times.

Things you should have with you:



Safety First!

Fire Safety

In the Cabins or Meeting Rooms: If for some reason fire should break out in a building, it's the counselor's responsibility to evacuate her assigned individuals to a safe place. Confirm with other counselors that all delegates are accounted for in a safe place, then immediately report the situation to Daela and Courtenay. Never try to extinguish a fire - just evacuate.

On the Campground: If a brush, grass, or car fire should occur on the campus it's the responsibility of the counselors to evacuate all delegates to a safe place. Work with each other to ensure all delegates are accounted for and immediately report the situation to Daela and Courtenay. Don't attempt to extinguish the fire.

In the Event of a Fire Drill: Always be listening for the fire alarm. If you hear it, evacuate your delegates to the designated meeting place.

Bear Safety

We're in the woods and there are bears. Please be alert!

- If you see a bear, contact Daela or Courtenay IMMEDIATELY!!
- If you hear Daela or Courtenay yell something unusual (like "Get in the nearest cabin!"), **respond quickly and calmly, without question.** You'll be updated as need.

Water Safety

At the Lake: The lake isn't approved for swimming without the pre-approved presence of lifeguards. For this reason, the lake is gated off from the campus. Only the Director, with permission from the Camp Manager, may approve the use of the lake. Circumventing the fence in any way by any person is in violation of the rules established by our facility and may result in the dismissal of the violator from the program.

Problem Situations at Nevada Girls State

Brace yourself, here come the problems ... It's true that the session is a wonderful world all its own. It is the perfect environment for building strong friendships and indestructible bonds between delegates and counselors alike. There is no place or time in life that can compare with the unique, seemingly perfect environment of the session.

Problems in camp can range from personality conflicts to fights to homesickness and more. **The following section is extremely important.** It deals with some common problems during the session and how you can deal with them. Be sure to familiarize yourself with the following information:

1. Make sure your actions dealing with problems are sound and that they uphold the Nevada Girls State code of conduct.

2. *Talk to the other counselors; remember that you have a support system.* **DON'T GOSSIP!** And remember that Daela and Courtenay aren't scary - we're actually pretty fun to be around.

3. Never make a statement or inform a delegate of consequences that haven't been approved by the Director. Don't threaten delegates or tell them you're sending them home (such as "one more time and you'll go home). Only the Director can send a delegate home.

Stealing (or unexplainable loss of personal property)

Stealing, like homesickness, has a way of being a part of nearly every session. Whenever a large number of people get together, certain situational elements exist that seem to contribute to this problem, whether at Girls State, a residential hospital, or an Army barracks. In a group-living situation, delegates need to be more careful about keeping their possessions together. Greater care needs to be taken to make sure valuables aren't left unattended and in a way that would temp another delegate.

If a delegate reports a missing or "stolen" item to you, ask the delegates to do a quick search of the cabin before reporting to Daela or Courtenay. You **MAY NOT** search through the personal possessions of the delegates. Often, the missing/stolen item is under a pile of clothes or still in the delegate's suitcase. The sad and unfortunate fact is that once something has been stolen, very little can be done about it. In fact, two people have suffered - the victim and the victimizer.

If a delegate would like to, she may entrust her valuables to the Director. These will be locked in a fireproof safe to which only Daela and Courtenay have keys.

Homesickness

First impressions are lasting, and what happens during the first few hours of the session is important for the inexperienced delegate. When they get to Girls State, it's like going to a different country. Everyone they know and really depend on is somewhere else, especially Mom and/ or Dad. Despite their age, delegates may still suffer from homesickness.

The homesick delegate generally will behave in one of two ways. The **first** is when they withdraw from their peers and want to be by themselves. They might be a little edgy or sensitive to the others laughing and joking around, especially when others try to include them. If there is a group activity planned they will no doubt want to stay in the cabin or watch from the sidelines. Food will be of little interest. In fact, they may try to convince you that they should stay in the cabin and miss meals. Finally, the homesick delegate will want to talk about good experiences they have had at home or what their families have been doing. While some of this is necessary for the way our program functions, too much of it may indicate homesickness.

The **second** way a homesick delegate may behave is to be overly outgoing, sometimes to the point that they're hardly bearable. They, too, will talk or brag about the great things they can do at home or great successes they've had. They will want to think they are outstanding so they will be accepted in the group and not feel lonely any more. Again, some of this is necessary in campaigning for elections, but too much of it, or doing it at inappropriate times, is a red flag for homesickness.

Homesickness is prone to make its unwanted appearance during our session when any delegate has a chance to think about what they left behind and when the future of the session doesn't look too exciting. One of the best ways to forestall it is to keep individuals excited for all activities.

Stick with the delegates closely for the first few hours and work hard at bonding them together in a feeling of "one-ness," since you're laying the foundation for the success of the whole session. Seize opportunities for informal chats, individually, in small groups, and as a whole group so all of you become old friends and can act perfectly natural with each other. Try particularly hard to draw in the "loners" and spot the mischiefmakers and misfits.



Fatigue

As Thomas Dekker said, "Sleep is the golden chain that ties health and our bodies together." The busy nature of our session makes delegates and counselors breathe a sigh of thankfulness for lights out at the end of the night. However, life at Nevada Girls State is extremely fast-paced and the days are long. Additionally, teenage girls often want to stay awake and chat instead of taking advantage of the time allotted for sleep (college life will teach them better). Signs of fatigue may include restlessness, irritability, excitable talking, undue noise, and paleness. When delegates begin to exhibit these signs of fatigue they will require you as a counselor to be more sure of how to contain them as a group. You will need to be stricter in making sure they do what's expected of them, whether it's to listen attentively to a speaker or be on time to a meal.

How to Advance an Indoor Flag


When setting the flags, you'll need to tip the base at an angle, put the flag pole all the way % f(x)=0 into the base, and then stand the flag up

The US flag should be stood into place first

When the flags are up, the eagles on top should face the delegates in the chairs

Delegates advancing the flags should remain next to the flags for the Pledge of Allegiance

How to Retire an Indoor Flag




Flags should wind up next to the entrance/ exit doors

How to Fold an Outdoor Flag


Fold widthwise twice

- 1. Hold flag flat
- 2. Fold bottom up

PRO TIP: The bottom edge should come to the straight line (the upper 2 corners) of the top row of stars (now you mostly see stripes)



3. Fold bottom up again (this time the edges come together; *now you see stars and stripes again*)



Corner your flag person on the Stripes end folds

- 4. Start at striped end
- 5. Fold bottom corner up to create a triangle

PRO TIP: Folding the flag is easiest if you make sure to held the flag tight the whole time

Continue cornering

6. Keep making triangles until you have one rectangle (only stars) and one triangle (only stars)

PRO TIP: You should make 9 triangle folds in all



- Fold the white edge in along its long side once.
- Fold the top corner down (now the whole flag should be one triangle)
- 9. Tuck the thinner triangle into the thicker triangle

Pod Meetings

Purpose of Pod Meeting:

A Note on Safe Spaces: A safe space allows a small group of people to build community, reflect on the day, and listen to experiences, hardships, and successes being had by all. By "safe space" - it is important to note that this is truly that: safe. Opinions on various activities are encouraged, and we as a group will strive to listen, even when we feel as if we can't agree. It is not appropriate in this space to allow comments to hurt others in any way; it is appropriate to find shared experiences that will allow us to better understand our differences. The week will be long, tiring, wonderful, and sometimes frustrating. We need people to reflect with. We need people that will hear us without judgment, and challenge us to think and dig deeper.

Pod Leader Instructions and Guidelines:

- **1. Start with why**. Share the purpose of the pod meetings, and establish your expectations.
- **2. Icebreakers are good**. Everyone in that room should know each other's names, and actually strive to learn things about each other. Build community. You're stuck with each other all week.
- From there, you can go in many different directions, and often your pod will take itself where it needs to take itself, but you might start with one of the discussion topics to the right, especially on the first day.

Possible Discussion Topics

General Inquiries to make:

- ♦ How did you feel about today?
- ♦ What have you learned?
- What thoughts/questions/ideas did you have during any activity that you didn't share or didn't have the chance to share? Why?
- ♦ What have you learned/accomplished today?
- ◊ Did you accomplish everything you wanted to accomplish?
- ♦ What goals do you have for tomorrow?
- ♦ How were your interactions with other delegates today?
- Rose/Bud/Thorn Activity One thing you appreciated about the day (Rose); One thing you're looking forward to (Bud); One thing that was challenging (Thorn) (not necessarily in that order)

Questions for the last night:

- ♦ How do the things you have learned apply to your life outside of Girls State?
- Have you seen any changes within yourself over the week?What are they? How can you take it to the outside world?
- ♦ What will you miss most about the week?

attorney general: an elected official who serves as the chief legal advisor of the State, prosecutes and defends cases in the State Supreme Court, exercises supervisory power over District Attorneys, and may represent the interest of the State before high courts

bicameral: of a legislative body, having two branches or chambers

POLITICAL PARTY OFFICIALS

PARTY CHAIR: Each of the two parties has a Party Chair. The chair is elected at the first meeting of the political party. It will be her duty to preside at all meetings of the party. The Party Chair will run the party meetings and keep track of the committees formed within the party. The goal for each party is to have more people elected from their party than the other party. The Party Chair will also encourage members of her party to run for elections as well as help with resolutions. Finally, the Party Chair will work as a team with the Party Secretary and will work closely with Courtenay Burns.

PARTY SECRETARY: Each of the two parties has a Party Secretary. The Party Secretary will help run the party meetings and keep the notes for those meetings. She will be available to assist any of the committees with drafting bills and will keep a record the bills written.

The Party Secretary will help with resolutions and will see that the party has written resolutions. She will help members of her party type resolutions and submit them to Courtenay Burns. She will also keep a record of the resolutions of her party and a list of the committee memberships for her party. The party secretary will work as a team with the Party Chair and will work closely with Courtenay Burns.

The Party Chair and Party Secretary are also free to write their own resolutions and/or serve on committees within the Party.

ELECTED CITY OFFICIALS

MAYOR (1): Each city has a Mayor who is the chief executive officer of City government. She presides at all City meetings. She is also responsible for the performance of City functions, such as creating the City song and ensuring that all citizens of her City help with assigned chores and duties and those chores and duties are successfully completed. The Mayor, like all City officials, has the special function of encouraging City unity and enthusiasm and promoting happiness in her City. The Mayor will also ensure that all citizens of her city are present at all functions and that all citizens of her city have voted. Furthermore, the Mayor will facilitate discussion within her City about all resolutions.

CITY COUNCILWOMEN (4): The Councilwomen form the legislative body of City government. They enact ordinances and adopt resolutions, which may be presented by any citizen. The City Council approves the budget of the city. The City Councilwomen will be helping the Mayor and the Deputy Mayor in their duties as city leaders.

CITY ATTORNEY (1): The City Attorney or her assistant represents the City in legal matters in which the City is involved. She acts as legal advisor to all City officials and acts as their counsel if suit is brought by or against them.

DISTRICT JUDGE (1): The District Court is a trial court of general civil and criminal jurisdiction and has broad powers in relation to the persons, subject matter, and disposition of the cases referred to it. Most civil and criminal cases have jury trials, with notable exceptions being the Family Court and the Juvenile Justice Court.

APPOINTED CITY OFFICIALS

(made by the Mayor)

Deputy Mayor: The Deputy Mayor will be appointed from the other city cabin and is responsible for supporting the Mayor in her duties.

Fire Chief: The Fire Chief is responsible for the management and supervision of the Fire Department. She enforces the City's fire and safety laws. At Girls State, she should ensure the city observes the smoking rules and knows the fire drill procedures.

Deputy Fire Chief: The Deputy Fire Chief will be appointed from the opposite cabin of the Fire Chief and is responsible for supporting the Fire Chief in her duties.

Commission on Public Safety: The members of the Commission on Public Safety will be responsible for ensuring that all safety regulations are enforced (such as ensuring cabin doors are closed and no food is brought into the cabins). The members of the Commission will also serve as the first contacts should an emergency situation occur.

ELECTED COUNTY OFFICIALS

COUNTY COMMISSIONERS (9): The powers of the County Commissioners are legislative, administrative, and supervisory in character. They include the levying of county taxes, the making and executing of the county budget, supervising the deposit and safekeeping of county funds, the managing of all properties of the county where there is no provision made by law, supervising the construction and maintenance of county roads, and supervising the carrying out of State laws within the county.

COUNTY CLERK (1): This official maintains a record of all deeds, mortgages, and other legal papers, and keeps these records open for public inspection. The Clerk issues marriage licenses and records certificates of marriage ceremonies. The Clerk will sign all county election forms.

COUNTY TREASURER (1): The Treasurer is the chief financial officer of the county. The chief duties are to collect the taxes levied on all property by the Assessor and to pay the bills of the county.

COUNTY SHERIFF (1): The Sheriff is the chief law enforcement official of the county, enforcing State laws within her jurisdiction and protecting life and property of the residents of the county.

DISTRICT ATTORNEY (1): The District Attorney or her assistant represents the State in legal matters in which the county is involved. She acts as legal advisor to all county and precinct officers and acts as their counsel if suit is brought by or against such office.

JUSTICE OF THE PEACE (1 PER DEPARTMENT): This judge presides in the Magistrate Court, which is mostly a tribunal for the trial of small cases and grievances. There is no jury system associated with the Justice of the Peace courts.

DISTRICT JUDGE (1 PER DISTRICT): The District Court is a trial court of general civil and criminal jurisdiction and has broad powers in relation to the persons, subject matter, and disposition of the cases referred to it. Most civil and criminal cases have jury trials, with notable exceptions being the Family Court and the Juvenile Justice Court.

COUNTY SCHOOL BOARD TRUSTEE (3 PER DISTRICT): The School Board determines public school policy in conformity with the State Board of Education, hires all personnel, and budgets and expends all monies reserved for education in each district.

ELECTED STATE OFFICIALS - PARTISAN

GOVERNOR (1): The Governor makes appointments, gives an inaugural address, addresses the joint session of the legislature, signs or vetoes bills, and represents Nevada Girls State for the ensuing year. THE GOVERNOR IS <u>NOT</u> ELIGIBLE FOR GIRLS NATION.

LIEUTENANT GOVERNOR (1): In case of death, impeachment, resignation, removal, or other disability of the Governor, the powers and duties of that office shall become vested in the Lieutenant Governor. Additionally, the Lieutenant Governor is tasked with bringing businesses into the State. The Lieutenant Governor shall be the President of the Senate, but shall vote only when the Senate is equally divided.

SECRETARY OF STATE (1): The Secretary of State maintains the State archives, attests all official acts of the Governor, and supplies written information on any subject when required to do so by the Governor. The Secretary also maintains records of corporations and organizations licensed to do business in the State. Additionally, the Secretary of State oversees and certifies all elections in the State.

STATE TREASURER (1): The State Treasurer receives and keeps State money, supplies the controller with receipts for money received, disburses money upon warrants drawn by the controller, and acts as the State's disbursing officer to the Federal government.

STATE CONTROLLER (1): The State Controller is the chief fiscal officer of the State and is responsible for administering the State's accounting system; settling all claims against the State; collecting debts owed to the State; and ensuring compliance with our Constitution, federal laws, and State statues.

ATTORNEY GENERAL (1): The Attorney General serves as legal advisor on all State matters arising in the Executive Department, prosecutes or defends State cases in the Nevada Supreme Court, supplies written opinions at the request of other State executive officers or State institutions, and exercises supervisory power over District Attorneys. The Attorney General may also represent the interests of the State before higher Federal courts.

STATE SENATORS (11): The Senators form the smaller of the two legislative bodies of the State. At Nevada Girls State, they will debate and enact the legislation of the session in coordination with the Assembly.

ASSEMBLYWOMEN (22): The Assemblywomen form the larger of the two bodies of the legislature. At Nevada Girls State, they will debate and enact the legislation of the session in coordination with the Senate.

SPECIAL NOTE REGARDING STATE ELECTIONS

Assemblywomen and Senators

There will be 22 Assemblywomen and 11 Senators. The Assemblywomen and Senators will be familiar with every resolution and will know the opinions of their constituents. On Thursday, they will make appointments, review resolutions, and practice for the Legislative Session. They will debate the resolutions and vote on them at the legislative session in Carson City on Friday. They will work very closely with Courtenay Burns.

Governor

The governor holds the highest elected office at Nevada Girls State. She should know her constituents and their opinions. She will make many political appointments. She will be familiar with every resolution. On Friday, she will address the Joint Session at the Legislative Session in Carson City. During the session, she will sit in the Assembly Chamber and observe the process. When both Houses pass a resolution, she will decide whether to sign it or to veto it. She will work closely with Courtenay Burns.

ELECTED STATE OFFICIALS - NON-PARTISAN

JUSTICES OF THE SUPREME COURT (5): The chief responsibilities of the Supreme Court are: interpreting the State Constitution, determining intergovernmental relations, and determining limits of executive and legislative action.

STATE BOARD OF EDUCATION (5): The State Board of Education enacts educational policy and requirements for the entire State. This does not include budgetary powers.

BOARD OF REGENTS OF THE UNIVERSITY (5): This board prepares the budget for the entire University system, includes community colleges, makes policy concerning and sets goals and standards for both the faculty and the students.

How to Write a Resolution

The whole week of programming at Nevada Girls State is set up to take us to a mock legislative session. Throughout the week, we'll work together to craft legislation about issues that are important to you. In order to make this process move along as smoothly as possible, we ask all our delegate to come prepared with a resolution.

DON'T PANIC! This document will help you get started and the staff will help you refine your resolution during the session.

We want your experience to be as close to how things really work as possible. In order to make this happen, there are a few rules on what topics can be addressed at Nevada Girls State:

- Only issues that can be addressed at the state level. ٠ Because this is NEVADA Girls State, all topics must be at the state level. What does this mean? Some topics can't be legislated by the State because they are outside of its jurisdiction, notably those that are strictly local issues (such as zoning) and those that are strictly federal issues (such as Yucca Mountain).
- All resolutions must abide by the Nevada Constitution and the Constitution of the United States.

The Nevada Constitution and the Constitution of the United States are the governing documents for our legislature and so we abide by them as well. This means that legislation can't seek to do such things as establish a religion for Nevada or limit freedom of the press (because freedom of religion and freedom of the press are protected by the U.S. Constitution). For this reason, we don't allow resolutions that seek to regulate abortion, because this is protected by the Nevada Constitution.

Resolutions can't duplicate existing laws.

If your resolution doesn't comply with one or more of these rules, don't worry - the staff WILL help you to work out the kinks.

Let's get started!

Features of a Girls State Resolution

- A **PREAMBLE**, which states the purpose of the resolution
- WHEREAS clauses, which each give one (1) reason why this resolution is needed. (You may include as many WHEREAS clauses as you need to give the reasons for supporting your resolutions, as long as they're relevant.)
- A **RESOLVED** clause, which states the final objective.

Formatting

The following shows you how to format each element of your resolution. You'll need to use this exact wording and punctuation. Portions in italics will be what you write.

- Your first and last name at the top of the page ٠
- Single-spaced
- The first line of each resolution will start with: Memorializes the 2017 session of the Nevada Legislature to enact legislation that will... (This is then followed by your PREAMBLE.)
- Each WHEREAS clause (except the last one) will be formatted like this:

WHEREAS, (one reason for why this legislation is need); and

- The final WHEREAS clause will be formatted like this: WHEREAS, (your final reason for why this legislation is need); therefore, be it
- The RESOLVED clause will be formatted like this: RESOLVED BY THE GIRLS STATE OF NEVADA, assembled in Carson City on (Date), 2015, that the 2017 Session of the Nevada Legislature is hereby memorialized to enact legislation that will... (Restate the purpose of your resolution.)

An Example Resolution

(The following Resolution was written and passed during the 2014 session.)

Memorializes the 2015 session of the Nevada Legislature to enact legislation that will mandate vision and hearing tests for elementary school children to ensure that parents are aware of problems that affect their child's hearing.

WHEREAS, Children and their parents often do no realize that the child has these problems; and

WHEREAS, Students who start to heavily focus on reading in third and fourth grade will have many problems comprehending the text if they cannot see properly; and

WHEREAS, Elementary students who have hearing problems and cannot hear directions or warnings well can be in danger; and

WHEREAS, Children who have visual and/or hearing difficulties may feel alienated from children without difficulties; and

WHEREAS, If the problem is identified, children will prosper and have a higher self esteem; and

WHEREAS, School nurses shall be trained in identifying and testing for vision and hearing problems; and

WHEREAS, Students who receive hearing aids and/or glasses can then get help, which can bring these students who are behind back up to grade-level standards; therefore be it

RESOLVED BY THE GIRLS STATE OF NEVADA assembled in Carson City on July 3, 2014 that the 2015 session of the Nevada legislature is hereby memorialized to enact legislation to mandate vision and hearing tests for elementary school children.


